- all horses are purchased "voetstoots", which means on an "as is" basis. No warranty is given in respect of, inter alia, the fitness, soundness, condition or quality of any particular horse offered for sale;
- the purchase price & any other charges including VAT in respect of any horse is payable within 21 days from "the fall of hammer" on any lot purchased by the Applicant;
- This application does not constitute a credit agreement;
- All overdue amounts will be subject to an administrative charge of 2% per month;
- before leaving the sales premises, all horses purchased must be insured for a period of at least 90 days (see above*);
- All insurance will be confirmed with the above Broker*. If the broker declines insurance, BSA will automatically insure the horse. The insurance costs will be charged to the buyers' account, and the buyer will be responsible for payment of these charges;
- I hereby declare that I am not under debt review, an administration order or sequestration proceedings;
- I confirm that I am able to pay all of the amounts for every lot purchased by myself at this sale;
- I am acting in my own capacity in purchasing the horse. Alternatively if I am purchasing the horse on behalf of another person, I have completed the authorisation form and the buyers' card in the name of that party;
- In compliance with the POPI Act, I hereby consent that my information as a purchaser is allowed to appear in Bloodstock SA sales reports and used in the Bloodstock SA database;
- In the event that for any reason whatsoever I instruct Bloodstock SA to invoice another party for any purchases, I accept that I shall be personally responsible for all amounts due for every lot purchased by myself at this sale in the event of the other party failing to make payment for any such lot;
